

Anne Arundel County Hotel Relief Grant Program Final Report

Executive Summary

As the COVID-19 pandemic continues to impact our nation, Anne Arundel County's accommodation providers such as hotels, motels, and bed & breakfast establishments continue to be hit hard. Travel restrictions over the past year, combined with other limitations and the general public's reluctance to travel, have significantly hurt these businesses' revenues and employees. The Maryland General Assembly and Governor Hogan, through multiple emergency relief measures including using "Rainy Day Funds" and passing the RELIEF Act of 2021, allocated specific funding to the Maryland Department of Commerce to help this subset of hospitality businesses. Commerce partnered with Anne Arundel County, which tapped Anne Arundel Economic Development Corporation (AAEDC) to develop and disperse these desperately needed funds to county's hotels, motels, and bed and breakfast establishments.

The Hotel Relief Grant (HRG) program was conducted in three rounds. Rounds one and two were funded through state "Rainy Day" funds and went to bed and breakfast establishments with at least five rooms and hotels and motels with at least 10 rooms that demonstrated a reduction in revenue of at least 25% for the period of April 2020 through November 2020 compared to the same period in 2019. These businesses were given grant funds in round one based on a predetermined amount per room up to a maximum of 100 rooms. These grant funds were permitted to be used for normal operating costs and/or the purchase of PPE, sanitization services, or other COVID-19 related costs. Rounds one and two ran from February 19th through March 5th, 2021 and the final grant amount was determined to be \$1,900 per room, with a maximum grant amount of \$91,300. A total of 62 grants were awarded totaling \$5,072,500.


In round three, which ran from March 25th through April 9th, the State of Maryland narrowed the eligibility requirements to locally-owned establishments. State funds totaling \$894,500 were awarded to 50 hospitality businesses; five to new applicants and 45 to previous applicants that were locally-owned establishments. These applicants received \$25,000 and the remaining amount was divided equally at \$17,100 to each accommodations provider.

Upon completion of the Hotel Relief Grant program, AAEDC dispersed grants to 67 accommodation provider businesses for a total disbursement of \$5,967,000 in state funds.






Breakdown by Accommodation Provider Type






By Minority/Woman/Veteran Ownership*



By County Council District



Distribution by County Council District




By State Legislative District




Distribution by Legislative District
